## Section 1: Introduction

### About this Statement

Today, there are 50 million people around the world estimated to be trapped within the many forms of Modern Slavery. This includes human trafficking, forced labour, debt bondage, descent-based slavery, the worst forms of child labour, forced marriages and domestic servitude.

At Aliaxis, we oppose slavery in all its forms.

Aliaxis is committed to identifying and preventing any potential modern slavery risks within our operations and supply chains. We are pleased to submit this Modern Slavery Statement for the reporting period of 1 January 2024 - 31 December 2024.

The content of this Statement is focussed on the Aliaxis Operations within Australia and New Zealand. This Statement also meets the requirements of Vinidex Pty Limited as a reporting entity for the purposes of the Australian Modern Slavery Act 2018 (Commonwealth). This Statement is voluntary for Philmac Pty Limited, Marley New Zealand Limited, Dynex Extrusions Limited and RX Plastics Limited. This Statement describes the actions taken and planned during the reporting period to assess and address any modern slavery risks in our operations and supply chain.

### A message from our CEO

At Aliaxis, we aim to act responsibly and treat each other with respect, anchored in our behaviours: we dare, we care, we deliver.

Throughout 2024, our Aliaxis Asia Pacific team continued to execute our modern slavery risk assessment and management framework, focused on our external supply chains. There were no instances of modern slavery identified during this reporting period. However, we acknowledge that managing modern slavery risk is complex, and the risk landscape is ever evolving. We remain committed to investing into this work and increasing our framework maturity.

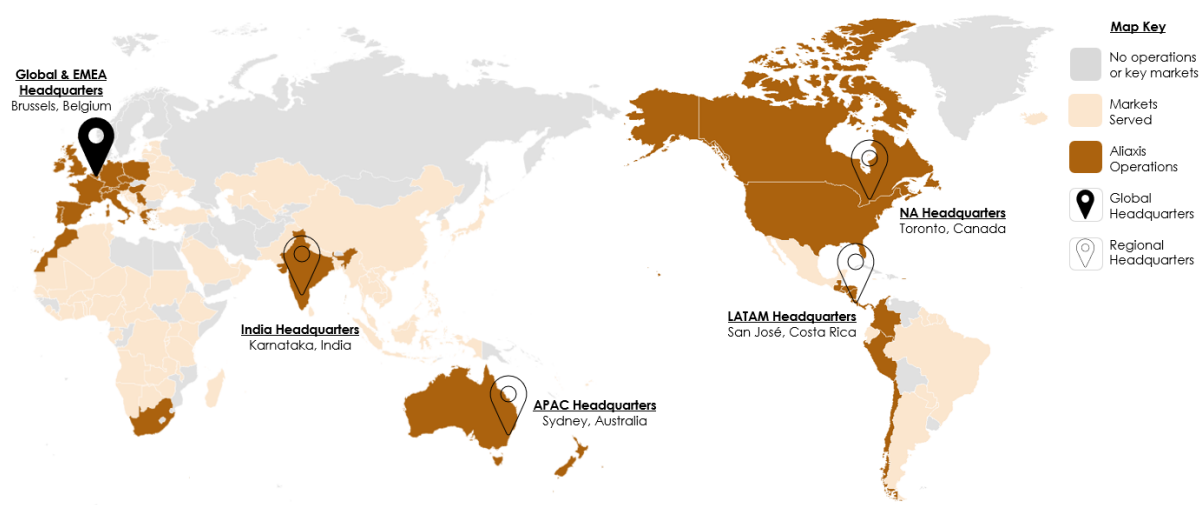

This includes trading brand Rodney Industries, as well as two subsidiary businesses which transferred their assets and businesses to Vinidex in 2024, which were formally Yatala Plastics Pty Ltd and Zezt Pty Ltd. In Australia, Aliaxis also owns Philmac Pty Ltd. Within New Zealand, Aliaxis owns Marley New Zealand Ltd, Dynex Extrusions Ltd and RX Plastics Ltd.



## Section 3: Business Ethics and Compliance

### Global Ethics and Compliance Governance

Aliaxis has a consistent Global Framework across critical areas including Human Resources, Health, Safety, and Environmental Sustainability.

Ethics Governance	At Aliaxis, we are firmly committed to conducting our business with integrity and trust. We have an Aliaxis Code of Ethics, applicable to all employees, which describes our commitments to our people, to sustainability, and to the law. Our Global Alert Channel allows internal and external stakeholders to report misconduct and policy violations. As part of our onboarding process, office-based employees are required to complete annual Ethics Training.
Legal & Regulatory Compliances	Aliaxis has a global framework to ensure all legal and regulatory compliances are maintained. This includes Policies and Training Programs on Market Abuse, Anti-bribery and Corruption, Competition Law, and Privacy. We also have a Trade Compliance Policy, supporting management structure, and Business Partner Screening process using our third-party Compliance Screening Tool.
Human Resource Management	Aliaxis is dedicated to adhering to all relevant country regulations and labour laws. Our local HR managers ensure these compliances, freedom of association, work life balance, the right to collective bargain, and fair equitable remuneration. Aliaxis has a global HRIS Platform for process management from recruitment to retirement. Aliaxis APAC continue to run a Diversity, Equity and Inclusion (DEI) Council, a biannual employee culture survey, and an annual Local Heroes Program to recognise and celebrate our employees.
Health, Safety & Wellbeing	Health and Safety is a core value within our organisational culture. Aliaxis has a belief that "All injuries can be prevented" together with eight "Go For Zero" guiding principles to govern our leadership vision and decision making. We have developed a global H&S improvement strategy built on foundational pillars of "culture & behaviour", "management of key risks" and 'ways of working'. We have established objectives and targets subject to monthly HSE performance reporting and review through all levels of the organisation. Aliaxis APAC promotes employee consultation and involvement through programs like Hazard Made Safe and Positive observations included in daily tiered communication forums. We provide an Employee Assistance Program (EAP) and actively promote health & wellbeing through a range of initiatives such as Global Safety Week and RUOK day events.
Sustainability	Aliaxis has a strong Sustainability framework. We are audited by Ecovadis, with focusses on Environmental, Social and Governance (ESG). Aliaxis signatories to the UN Global Compact. Aliaxis is also a member of the Sustainable Procurement Pledge (SPP).
Best Practice Awards	Our 2024 Aliaxis Global Best Practice Awards received over 280 submissions. Vinidex won the Gold Operations Award for their Maintenance Excellence Initiatives. Marley, Dynex and RX Plastics won the Gold Sustainability award for their Operation Clean Sweep Program to protect local waterways. Vinidex also won the Bronze Sustainability Award for their work to reduce water consumption.

## Our Supply Chains

Aliaxis Operations in Australia and New Zealand rely on a network of over 4000 total suppliers. Of these suppliers 77% are based in low-risk countries, primarily in Australia and New Zealand. Where possible, we strive to support domestic businesses. Our supply chains span more than 30 origin countries, including strategically partnering with international suppliers for critical raw materials, manufacturing equipment, and specialised finished goods. Additionally, Aliaxis maintains intercompany supply chains. Most of our intercompany spending occurs within the Aliaxis ANZ business, while minor transactions extend to Aliaxis Europe and Aliaxis North America.

Our Aliaxis Operations within Australia and New Zealand are proud to have been operating an established Modern Slavery Framework for the last five years. Below is an overview of the key components of our Framework.

## Identified Potential Modern Slavery Risks

After completing our Modern Slavery Risk Assessment process across our over 4000 suppliers, we did not find any confirmed instances of Modern Slavery. We did identify the following potential risks within our supply chains:

Domestic Geographic Risks	By count, over 90% of our active tier one suppliers are also based in Australia and New Zealand. Although always a potential risk, the Modern Slavery Index confirms low prevalence, low vulnerability, and low percentages of both Australian and New Zealand's populations as potentially subject to Modern Slavery practices.
International Geographic Risks	Although the minority of our suppliers are based internationally, together they make up a significant portion of our total spend. We have identified over 30 origin countries within our supply chains. We have assessed the varying geographic risks for each known origin country utilising data from "The Modern Slavery Index" published by the Walk Free Foundation.
Industry and Sector Specific Risks	Our taxonomy classifies our spend into 23 tier one industries. We identified 5 of these industries as having higher potential Modern Slavery Risks, based on findings from the "Global Slavery Index" now published by the Walk Free Foundation. These are Facilities Management, Factory Consumables, Human Resources, IT/Telecom and Professional Services.
Supplier Specific Risks	We also acknowledge there are entity specific risks which our suppliers have the responsibility to manage through their own corporate governance, legal compliance, and effective risk management. Aliaxis APAC has developed criteria to prioritise which Suppliers we request complete our Modern Slavery Self-Assessment Survey every year. These are used to foster Supplier engagement and validate assumed risks, to then inform our Risk Management work.

## Section 6: Actions Taken to Assess and Address Modern Slavery Risks

### Modern Slavery Risk Assessment

Our 2024 Modern Slavery Risk Assessment process included the following actions:

#### Strong Governance during Sourcing

Our Aliaxis Operations in Australia and New Zealand have developed strong regional Corporate Governance in the process to Source new suppliers. Our **Procurement Playbook** continues to be our internal guide for undertaking all regional Procurement activities. It details process requirements for conducting supplier Modern Slavery Risk Assessments, and on numerous occasions has resulted in ceasing consideration of suppliers. In 2024 Vinindex launched a **New Supplier Request Process**, which also includes automated Modern Slavery Risk Assessment to ensure every new Supplier has been risk assessed and approved before business commences.

##### Case Study: Risks identified during sourcing

We discovered that an active raw material was originally manufactured in Qatar. The Modern Slavery Risk Assessment process embedded in our Procurement Playbook indicated a geographic based risk. Attempts to further discuss and assess elevated risk levels with both the distributor and the manufacturer were not supported. Further red flags were identified. We resourced the material to an alternative supplier.

#### Desktop Risk Analysis

Our annual Modern Slavery Desktop Risk Analysis was conducted across all suppliers to our Aliaxis Operations in Australia and New Zealand. We have developed a Risk Analysis tool, which utilises a combination of internal and external data points. Our objective is to continually increase our understanding of our supply chains, and to identify higher risk areas for further investigation:

- Aliaxis Supplier & Supply master data
- Aliaxis Supplier Specific risk data
- Aliaxis previous year risk assessment results
- External Geographic risk data
- External Industry & Sector risk data

#### Modern Slavery Risk Assessment Survey

Our annual Modern Slavery Risk Assessment Survey was sent out to targeted suppliers. We received over 130 completions within 2024. Survey results were assessed and rated. Our Survey has strong focusses on:

- Employment Conditions
- Child Labour & Forced/Bonded Labour
- Human Trafficking
- Supplier Policies & Controls
- Supplier Supply Chain Risk Management

## Modern Slavery Risk Management

After assessing our potential Modern Slavery risks, we executed the following Risk Management initiatives for our Aliaxis Operations in Australia and New Zealand.

Supplier Risk Management Collaboration	Collaborating with our suppliers on Modern Slavery continues to increase awareness across our supply chain. Our Procurement team worked alongside our suppliers to better understand their practices, Modern Slavery Statements, and Survey responses. Where a potentially higher risk level was indicated, we sought to validate the risk, consider any remedial actions required, promote our Modern Slavery Framework, and reiterate our expectations.
Supplier Contracts & Code of Conduct	<p>We have been working to significantly increase the proportion of our spend under Contract. Utilising formal Agreements strengthens our supplier governance, and ensures our strategic partners are explicitly clear of our Modern Slavery Risk Management requirements. Our Supplier Contracts all now include our Supplier Code of Conduct. We also proactively reached out to active top tier suppliers asking them to acknowledge it, to ensure our expectations are understood.</p> <div> <p><b>Case Study: Refusal of Supplier Code of Conduct</b></p> <p>A raw material manufactured in Saudi Arabia was being considered for a trial. A geographic based risk was identified. A deep dive was conducted with the supplier. An impasse was reached when they refused to agree to or acknowledge understanding of our Supplier Code of Conduct. No commitment was made to address the concerns raised. Sourcing consideration was ceased.</p> </div>
Modern Slavery Training Program	Aliaxis has a Modern Slavery Awareness Training Program, which was developed by a third-party specialist organisation. The content focusses on defining Modern Slavery, explaining how it can occur, sharing regionally relevant Case Studies, how to spot red flags, and where to escalate any identified risks. Within 2024 we expanded role coverage, resulting in completion by more than 30 additional staff members. We introduced a requirement to repeat this Training at least every two years. We also further integrated this Training within our overarching compliance framework, by moving it from a third-party website into our Aliaxis global Training platform.
Trade Compliance Framework	As part of our Trade Compliance Framework, all our Aliaxis suppliers are screened through a third-party Risk Management tool powered by Dow Jones. This includes human rights violations prosecuted or as of 2024 also accusations within adverse media reports. We receive alerts on any new high risks identified, to ensure swift responses and action, as required.



## Framework Continuous Improvement

We are committed to continually improving our Modern Slavery Framework. Below is an overview of key improvement initiatives undertaken in 2024.

Risk Assessment Logic Updates	Updates were made to our Desktop Risk Analysis logic, and increased automation was introduced for quick and consistent review of completed Modern Slavery Supplier Surveys. We classified Survey questions as being of either gold, silver or bronze standard for quick benchmarking and tracking.
Operational Embedding	In 2024 Vinidex launched a New Supplier Request process, which includes an automated and fully embedded Modern Slavery Risk Assessment. This system-based control has proved very successful. It will be further launched across Philmac and New Zealand in 2025.
Governance Updates	Within 2024 we updated several governance components, including our Anti-Harassment and Non-Discrimination Policy, Supplier Contract templates, our Procurement Playbook, and our regional Purchase Order Terms and Conditions.
Vinidex Connect Program	Connect is a global program by Aliaxis to launch standardised processes underpinned by a consistent ERP platform across our businesses. Following Vinidex's launch in January 2025, all Direct and Indirect Spend purchasing practices have been consolidated and systemised for improved traceability. Our new ERP includes new Taxonomy and Country of Origin fields required in our annual Modern Slavery Desktop Risk Analysis.

## Section 7: Assessing the Effectiveness of the Actions

The following is in place to assess the effectiveness of our Modern Slavery framework.

Annual Program Review	Our Aliaxis Procurement team have undertaken a postmortem review of our Modern Slavery Framework effectiveness in CY 2024. A <b>Risk Assessment Results and Recommendations Report</b> was developed and reviewed. The impact of our Risk Management and Continuous Improvement actions were also assessed. While we celebrate the progress made, this review also produced recommendations and learnings for future work.
Executive Management Governance	Our Aliaxis Asia Pacific Executive Team, Global Procurement Director, and Global Sustainability Director are regularly updated on our Modern Slavery initiatives. This process is led by our Asia Pacific Procurement Director and Procurement team.
Feedback Loops	We are fortunate to have several sources of external feedback. We support Customer requests to review our Modern Slavery Framework, including completion of their surveys and follow up interviews. We also review a large volume of Modern Slavery Statements published by other businesses, including by Aliaxis UK, Suppliers and Customers.
Grievance Mechanisms	At Aliaxis we ensure that grievance mechanisms are available to our employees and parties within our supply chains. Aliaxis operates a global <b>Whistleblowing Policy</b> and <b>Ethics Alert Channel</b> , both of which were updated in 2024. There is a mandatory annual refresher training on required by all employees. The link is included in Section 5.

## Section 8: Our Consultation Process

### Consultation with Reporting Entities

During the development of this Modern Slavery Statement for CY 2024, we actively engaged and consulted with all our Aliaxis owned operations within Australia and New Zealand, as detailed within Section 4. During the consultation sessions with our entities, we discussed details of the Modern Slavery Act 2018, including our reporting requirements. We discussed our Risk Assessment process and results. We provided information on our Risk Management Action Plan to address the risks identified. We provided our entity stakeholders with relevant supporting materials and Framework updates.

### Consultation with the Entity giving this Statement

This Modern Slavery Statement is on behalf of our Aliaxis owned Operations in Australia and New Zealand. The issuing entity of this Statement is therefore Aliaxis Holding Australia.

As detailed within Section 2; Aliaxis S.A. (BE) is a privately owned business, with global headquarters in Brussels. We have an overarching Aliaxis Asia Pacific Executive Management team.

Post our consultation with each of our trading entities, we also held a consultation session with our Aliaxis Asia Pacific Executive Management team.
